**Volunteer University offers Education and Training modules in two different modalities**

Synchronous - Onsite in person, Virtual In-Residence Program (ViR) or other classes using various technologies

Asynchronous - Online through the Learning Management System/AXIS

Members can complete classes (modules) in one modality or a blend of the two

**Automated and Moderated modules**

Automated modules (A) are available to members in the Learning Management System/AXIS in the Level a member is currently working in. They are completed at a member's own pace and require a quiz to complete. Members are encouraged to work on automated modules while waiting for an onsite, ViR or other virtual class, or assigned a cohort to complete moderated modules.

Moderated Modules (M) require completion with a Volunteer University instructor in an onsite in-person class, through ViR or other virtual class, or through a cohort. Moderated modules only appear in AXIS after a member is assigned to a cohort. They will not appear in AXIS if completing onsite, through ViR or other virtual instruction with a Volunteer University instructor.

All modules are listed in Professional Levels regardless of the modality in which they are completed.

**Equivalency Credit**

Credit for some modules in each level are granted to those with equivalency based on prior training such as CAP Schools, cadet milestone awards, and Professional Military Education (PME). Proof of PME is sent to CAP NHQ at [Immeforms@capnhq.gov](mailto:Immeforms@capnhq.gov) for evaluation and entry.

All Level I modules are automated and available in AXIS for any member who wishes to complete them independently. Members can work with Volunteer University Instructors to complete modules. No cohort is needed for Level I.

Additional tasks are required to complete this level including a Summary Conversation with one of the following personnel after completing the *Cadet Protection Basic Course*: Commander, Deputy Commander, Deputy Commander for Cadets, Deputy Commander for Seniors, Director of Cadet Programs, Director of Personnel, Director of Education and Training, Personnel Officer, Education and Training Officer & Vice Commander.

After completing the *My Learning Path* module, members will have a conversation with one of the personnel listed above and choose the correct Level II path in Level I Professional Levels. This designates the correct Level II path for the member. Paths are Former Cadet, Former Military, Professional (as defined in CAPR 35-5), and New Member.
